RELATING TO THE BUILDING ORDINANCE OF CAMAS COUNTY, IDAHO
 ESTABLISHING A SCHEDULE OF FEES

BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS, CAMAS COUNTY, IDAHO:

That Title 2, Chapter 14, Section K, schedule of fees, authorized by Ordinance #169, be amended as follows, establishing the following schedule of fees replacing the fees established by Resolution # 163

The following schedule of fees is hereby established and replaces the fees established by Resolutions 163.

TOTAL VALUATION	PERMIT FEE Calculate Permit Fees from Table below
Agricultural Building	\$195.00
\$1.00 to \$500.00	\$35.00
\$501.00 to \$2,000.00	\$35.00 for the first \$500.00 plus \$5.00 for each additional \$100.00 or fraction thereof to and including \$2,000.00.
\$2,001.00 to \$25,000.00	\$110.00 for the first \$2,000.00 plus \$15.00 for each additional \$1000.00 or fraction thereof to and including \$25,000.00.
\$25,001.00 to \$50,000.00	\$455.00 for the first \$25,000.00 plus \$11.00 for each additional \$1,000.00 or fraction thereof to and including \$50,000.00.
\$50,001.00 to \$100,000.00	\$770.00 for the first \$50,000.00 plus \$8.00 for each additional \$1,000.00 or fraction thereof to and including \$100,000.00.
\$100,001.00 to \$500,000.00	\$1170.00 for the first \$100,000.00 plus \$6.50 for each additional \$1,000.00 or fraction thereof to and including \$500,000.00.
\$500,001.00 to \$1,000,000.00	\$3770.00 for the first \$500,000.00 plus \$6.00 for each additional \$1,000.00 or fraction thereof to and including \$1,000,000.00.
\$1,000,001.00 and up	\$6770.00 for the first \$1,000,000.00 plus \$4.00 for each additional \$1,000.00 or fraction thereof.

A plan review fee of up to 35% of the permit fee, on commercial building permits, may be required. A re-inspection fee of \$ 45.00 may be charged for all re-inspections. Double permit fees plus the original fee may be assessed for not obtaining the required permit.
