

**RESOLUTION NO. 220**

**A RESOLUTION AND ORDER TO CONSIDER DECLARING ABANDONMENT AND VACATION OF A PUBLIC ROAD AND OR RIGHT OF WAY IN CAMAS COUNTY, IDAHO IS IN THE PUBLIC INTEREST PURSUANT TO IDAHO CODE 40-203A(1).**

**WHEREAS** the Board of County Commissioners received a written request to abandon and vacate a portion of a public road or highway within Camas County, Idaho. **(Exhibit 1 and 1A)**

**WHEREAS** a public hearing pursuant to **Idaho Code §40-203** to determine whether the proposed abandonment of the highway is in the best interest of the public has been set for **December 9, 2024 at 2:00 p.m.**

**WHEREAS** it is the intention of said Board of County Commissioners to consider the abandonment and vacation of the following road and or right of way, **to wit:**

A section of S 700 W 200 S Road. Legal description: The public road in Township 1 South, Range 13 East, EBM, in Camas County, Idaho and proceeds south from an existing county road along the section line between section 28 and 29 for a total length of approximately ½ mile or less from the point of beginning to a point exactly two thousand six hundred and forty (2,640) feet south of the corner where sections 21, 20, 28 and 29 meet.

**BE IT RESOLVED AND ORDAINED BY THE BOARD OF COUNTY COMMISSIONERS FOR CAMAS COUNTY,** the effective date of this resolution and order shall be from the date of its passage by a majority vote of the Board of County Commissioners, Camas County, Idaho.

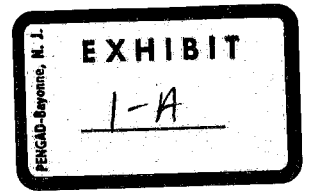
