SHALL THE CITY OF FAIRFIELD, IDAHO, BE AUTHORIZED TO INCUR AN INDEBTEDNESS AND TO ISSUE AND SELL ITS REVENUE BONDS IN AN AMOUNT NOT TO EXCEED \$1,500,000 TO PAY ALL OR A PORTION OF THE COST OF CONSTRUCTING IMPROVEMENTS TO THE WASTEWATER SYSTEM OF THE CITY, SAID BONDS TO BE PAYABLE SOLELY FROM WASTEWATER SYSTEM REVENUES, OVER A TERM WHICH MAY BE LESS THAN BUT WHICH SHALL NOT EXCEED FORTY (40) YEARS, AS MORE FULLY PROVIDED IN ORDINANCE NO. 279?

The purpose for which the proceeds of the bonds will be used is for improvements to the wastewater treatment and collection system. The City currently has \$691,989 of outstanding long-term indebtedness, payable from wastewater system revenues, and \$1,250,299 of outstanding long-term indebtedness, payable from water system revenues. The interest rate anticipated on the proposed bonds is 2.5%. The total principal amount to be repaid over the life of the bonds is \$1,500,000; the total interest estimated to be paid over the life of the bonds is \$875,419; the total amount to be repaid over the life of the bonds is \$2,375,419. The bonds will be payable over a term which may be less than but which will not exceed forty (40) years.
