

RESOLUTION NO. 221

A RESOLUTION AND ORDER TO CONSIDER DECLARING ABANDONMENT AND VACATION OF A PUBLIC ROAD AND OR RIGHT OF WAY IN CAMAS COUNTY, IDAHO IS IN THE PUBLIC INTEREST PURSUANT TO IDAHO CODE 40-203A(1).

WHEREAS the Board of County Commissioners received a written request to abandon and vacate a portion of a public road or highway within Camas County, Idaho. **(Exhibit 1 and 1A)**

WHEREAS a public hearing pursuant to **Idaho Code §40-203** to determine whether the proposed abandonment of the highway is in the best interest of the public has been set for **December 9, 2024 at 2:00 p.m.**

WHEREAS it is the intention of said Board of County Commissioners to consider the abandonment and vacation of the following road and or right of way, **to wit:**

A section of S 400 West and 200 South Road. Described as a public road in Township 1 South, Range 13 East, EBM, in Camas County, and proceed south from an existing county road along the section lines between sections 25, 26, 35 and 36 for a total length of approximately 1 mile more or less from the point of beginning to a point exactly five thousand two hundred eighty (5,280) feet south of the corners where section 23, 24, 25 and 26 meet.

BE IT RESOLVED AND ORDAINED BY THE BOARD OF COUNTY COMMISSIONERS FOR CAMAS COUNTY, the effective date of this resolution and order shall be from the date of its passage by a majority vote of the Board of County Commissioners, Camas County, Idaho.

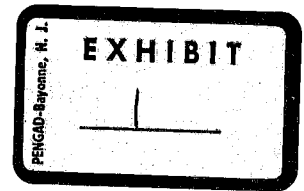

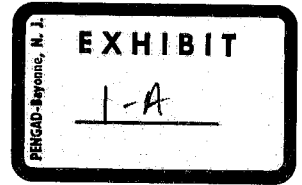


