



Camas Commissioner Meeting Minutes July 14, 2025

The meeting was called to order in the upstairs courtroom at 9:06 a.m. by Commissioner Kramer. Also present were Commissioner Ralph, and County Clerk Brianna Walter.

The Board reviewed the agenda. Commissioner Ralph motioned to approve the July 14, 2025 meeting agenda as posted, seconded by Commissioner Kramer, approved.

The Board reviewed the June 23, 2025 meeting minutes. Commissioner Ralph motioned to approve the minutes as corrected, seconded by Commissioner Kramer, approved.

The Board reviewed the June 23, 2025 brief synopsis. Commissioner Ralph made a motion to approve the synopsis, seconded by Commissioner Kramer, approved.

Commissioners reviewed a certificate of residency for CSI applicant. Motion by Commissioner Ralph to approve the Certificate of Residency for ID: #1003647. Seconded by Commissioner Kramer, motion passed.

Lynn McGuire, County Assessor Presented the Property Roll to the Commissioners.

Commissioners discussed the L2 Extension request from the Camas County School District. The Legislation passed a law giving extra time to the State Controllers Office on the distribution of funds to the Department of Education. Because of this extension, the schools do not know the number needed to put on the L2 for income received. Motion by Commissioner Ralph to approve the request for an extension after the State Tax Commission expressed that schools may need more time to complete the L2. Seconded by Commissioner Kramer, motion passed.

Commissioners discussed correspondence.

Leo Cavanaugh, Planning & Zoning Administrator, requested a date for public hearing for the Agricultural Protection Area Ordinance. Motion by Commissioner Kramer to table setting a date for the public hearing until Jim Thomas, Prosecuting Attorney is able to advise on ordinance. Seconded by Commissioner Ralph, item tabled.

Sonja Chrysler, City Clerk, presented Commissioners information on Delinquent Utilities to property taxes. Motion by Commissioner Ralph to approve adding the delinquent utilities to the property taxes, seconded by Commissioner Kramer, approved.

Jen Fredrickson, County Treasurer, presented June 2025 Treasurer Reports.

Commissioners reviewed June 2025 time sheets. Motion by Commissioner Ralph to approve the time sheets as corrected. Seconded by Commissioner Kramer, motion passed.

Commissioners reviewed the invoice for the Senior Center Calendar Listings and if they would like to continue having the meetings listed in the calendar. Motion by Commissioner Ralph to continue the listings, seconded by Commissioner Kramer, approved.

Commissioners reviewed June 2025 claims. Motion by Commissioner Ralph to approve the claims, seconded by Commissioner Kramer, passed. One claim remains for approval at the next meeting.
