



Camas Commissioner Meeting Minutes July 20th, 2026

The Board reviewed the agenda. Commissioner Ralph moved to approve the July 20th, 2026 meeting agenda as posted, seconded by Commissioner Colter. Approved.

The Board reviewed the July 13th, 2026 meeting minutes. Commissioner Colter moved to approve the minutes as corrected, seconded by Commissioner Ralph. Approved.

The Board reviewed the July 13th, 2026 brief synopsis. Commissioner Colter moved to approve the synopsis, seconded by Commissioner Ralph. Approved.

Commissioner Colter moved to go into Executive Session per Idaho Code 74-206(b) for personnel matters at 10:19 a.m. Seconded by Commissioner Ralph. Roll call, all in favor. Out of executive session at 10:53 a.m.

Lori & Jason Bergsma with Balanced Rock Insurance, Lori and Jason presented the health insurance program rates. Jason will get updated costs for the plan to start October 1st, 2026.

Josh Ashmead, Road & Bridge supervisor, presented his 2027 budget proposal to the board.

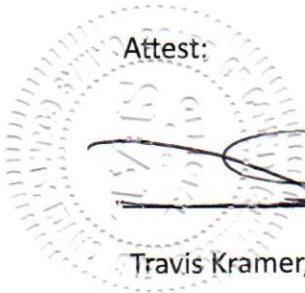
